1877 National Railroad Strike


In 1877 there was a national recession in the United States. One of the primary industries affected was the railroad industry. The Baltimore & Ohio Railroad Company had reduced their employees wages by fifty percent.


On July 11th, 1877 the Baltimore and Ohio Railroad Company announced an additional ten percent wage cut that would take effect on July 16th, 1877. On that day, July 16th a strike began at the Martinsburg Roundhouse. They shut down the Martinsburg yard, and obstructed incoming freight trains, only allowing mail and passenger trains to pass through. The West Virginia governor called in the state militia to end the strike. As the strike continued the President of the United States, Rutherford B. Hayes, sent federal troops to Martinsburg.

The strike spread to other Baltimore & Ohio Railroad Company sites, and then to other railroad companies across the nation. Some cities that were main sites of unrest were Pittsburgh, Chicago, and Baltimore. Governors from Pennsylvania, Maryland, and Illinois also called in their state militias to suppress the strikes by rail workers. The militiamen sent to Pittsburgh eventually joined the strike. National troops were then sent from Philadelphia to Pittsburgh.

The strikes eventually dissipated due to the disorganized nature of the strikes. There was no official leadership and a lack of communication between rail workers. The railroad strike last forty-five days. There were no tangible consequences to the National Railroad Strike of 1877 as no reforms were made to the wages or working conditions.

Quartermaster's Office Strasburg, VA Aug. 10, 1861

Col. Angus McDonald: My Dear Sir:

I introduce to your acquaintance and particular attention to my friend, Mr. Sharpe, the "Special Agent of the Confederate States." I have no doubt you are fully aware of the important services Mr. Sharpe has rendered in his prompt and successful removal of a large number of locomotives to this place form Martinsburg for the use of the Southern Confederacy. He has just returned from a most remarkable and eminently successful enterprise, vix., the removal of two splendid engines from Leesburg to Piedmont Depot on the M.J.R.R, the accomplishment of which has attracted the attention and elicited the admiration of all in that section of the country and the congratulations and thanks to the officers of the R.R Company. Mr. Sharpe now only needs your protecting wing to complete his valuable labours in another direction, the importance of which, I feel confident you will fully appreciate, and after his explanation and evidence of his authority to embark in the matter, will elicit your full approbation and protection. Knowing your eagerness to "prey upon the enemy" and engage in all that would add to our cause and their discomfort, I leave Mr. Sharpe to explain everything to you himself.

Martinsburg, Virginia March, 1862

The rebels have left their mark here. Forty-four locomotives stand on the track here-all a perfect wreck; a fine bridge, some 300 feet long, built on 16 stone pillars, formerly a splendid structure is now a heap of rubbish; 2-3 miles out of the city on the railroad track there is a deep run completely filled with demolished locomotives, passenger and other cars; the work-shops have been stripped of all their tools and machinery, and the wonder is that they too are not destroyed-even the turn-tables are all gone. It would be gratifying to see the fiends that accomplished this whole sale destruction of property hanging from tall gibbets along the ling of the operations. The Union vote in the county of Berkeley was 800.
